CHURCH RESOLUTION

Pursuant to the church resolution certified below, the above named church (hereafter referred to as the "Church") desires to establish membership at Florida Baptist Credit Union and authorizes the credit union to open an account for this business and any other accounts as the Church deems necessary. By completing this application, the Church agrees to conform to Florida Baptist Credit Union's bylaws and amendments.

The deposit account(s) shall be subject to the terms of the stated agreement, and any other deposit account(s) shall be subject to the terms as established by the account agreement or certificate agreement which establishes the account(s).

The Church agrees with Florida Baptist Credit Union that the persons listed on the attached signature card are authorized employees of this Church and may transact any business on this account on behalf of the Church, including, but not limited to, the following: depositing funds, withdrawing funds by any available means by which funds are withdrawn, issuing stop payments, endorsing drafts, certificates, or any other instruments, and transacting any business with the credit union necessary to carry out the purpose and function of the account(s).

The Church approves and ratifies any and all acts committed by authorized employees with regard to the account(s) with Florida Baptist Credit Union. The credit union is authorized to pay drafts, checks, notes, orders or withdrawals or to receive the same for credit of or in payment for the payee or any other legal holder when so signed, without inquiry as to the circumstances of the disposition of the proceeds, whether drawn to the individual order or tendered in payment of individual obligations of the persons named. The Church further agrees that all transactions conducted pursuant to authorized signatures shall be effective against the Church, whether or not authorized.

The Church agrees with the credit union that the terms of the membership application and the designated signers to act on behalf of the Church shall continue binding until written notice from the Church of a revocation thereof by resolution duly adopted by the Church and that the certification of the Secretary of the Church as to the signatures of the persons named shall have been received by the credit union. The Church further agrees that the credit union shall be indemnified against any loss suffered or any liability incurred by it in continuing to act pursuant to the resolution even though the resolution may have been changed.

Under the penalties of perjury, we certify that (1) the Tax Identification Number shown on this form is our correct Tax Identification Number and (2) we are not subject to backup withholding either because (a) we are exempt from backup withholding, (b) we have not been notified that we are subject to backup withholding as a result of a failure to report all interest or dividends, or (c) the Internal Revenue Service has notified us that we are no longer subject to backup withholding.
